COMMITTEE ON ACADEMIC PROGRAMS AND POLICIES (CAPP) CLINICAL PROFESSOR LEGISLATION OF 4 SEPTEMBER 2002 SEPTEMBER 14, 2011

- A proposal for use of the Clinical Professor title(s), once approved by the faculty of the originating college/school, will be submitted to CAPP for review of its conformity to the requirements of enabling legislation.
- Proposal will then be distributed or electronically posted for a period of 60 days before action by CAPP.
- If CAPP determines that the proposal meets the requirements of enabling legislation, it will report the proposal to the Senate.



PROPOSED USE OF CLINICAL PROFESSOR TITLE BY JOHNSON GRADUATE SCHOOL OF MANAGEMENT SEPTEMBER 14, 2011

- Peer schools have increasingly used the Clinical Professor titles, with very few peer schools lacking any 'professorial' title for non-tenure track faculty.
- Title issues are an increasingly important issue in the recruitment and retention of non-tenure track faculty.
- Clinical Professors will have substantive teaching and related responsibilities (career advising, project supervision, program development).
- Requirements include significant high-level teaching or business experience; terminal degree or substantial senior business experience (CEO, CFO, MD at major firm); external visibility and impact.



RESOLUTION FOR CLINICAL PROFESSOR TITLE IN THE JOHNSON GRADUATE SCHOOL OF MANAGEMENT SEPTEMBER 14, 2011

- WHEREAS the Clinical Professor title is available at Cornell, per Faculty Senate legislation of September 2002, and
- WHEREAS the Johnson Graduate School of Management (JGSM) has proposed to utilize this title, and
- WHEREAS the proposal was publicized more than 60 days ago;
- THEREFORE, be it resolved that the title Clinical Professor be available to the JGSM in accordance with their revised proposal of 16 December 2010.



NOTICE OF PROPOSED USE OF CLINICAL PROFESSOR TITLE BY COLLEGE OF VETERINARY MEDICINE SEPTEMBER 14, 2011

- "The primary function of the position Clinical Professor will be to provide clinical or diagnostic service to the College, Animal Hospital, or Diagnostic Laboratory, and to teach in that context..."
- "Research effort will not exceed 25% and is expected to be collaborative or consultative in nature."
- "The anticipated distribution of positions within the CVM is based on 25% of the tenure-track appointments within each department and the contributions of each department to clinical service."



NOTICE OF PROPOSED USE OF CLINICAL PROFESSOR TITLE BY COLLEGE OF VETERINARY MEDICINE SEPTEMBER 14, 2011

- "The impact of these positions will be in redistribution of titles among the non-tenure track faculty ... Some of the current lecturers/senior lecturers would be considered eligible for a clinical professorial title based on their credentials and accomplishments."
- Use of the clinical professorial titles ... will not require a reduction in the numbers of tenure-track faculty. Clinical professorial positions will be used strategically in units where greater teaching and service responsibilities are required than are allowed for a tenure-track position."



NAME CHANGE PROPOSAL FIELD OF IMMUNOLOGY SEPTEMBER 14, 2011

- The Graduate Field of Immunology proposes to change its name to "Immunology and Infectious Disease".
- Increased scope of Field enables inclusion of faculty studying animal pathogens but not the host immune response.
- No programmatic changes immediately accompany this name change.
- Field faculty have approved this proposal (11/11 to expand Field scope, 15/18 to adopt this specific name), as have 14 additional faculty members interested in joining the Field once the name has been changed.

- RFEI of 16 December 2010 Cornell responded March 2011
- RFP of July 2011; proposals due 28 October 2011

Proposal due	Oct. 28

Final decision	Late Dec.

 CAPP asked in March 2011 to serve as a cross-college faculty advisory committee to the Provost's office regarding Cornell's development of a proposal.



- CAPP's primary role to date has been to assess the strengths and weaknesses of different proposals for the academic organization of the CornellNYC campus, along with issues of concern for departmental cohesion and research efficacy, instruction, faculty hiring and governance, and the allocation and control of resources.
- Faculty committees drawn primarily from the College of Engineering and the Faculty of Computing and Information Sciences are planning the hubs, developing technology transfer options, and otherwise working on the proposal.



- On behalf of the Senate, CAPP has requested that materials detailing Cornell's response to the RFP be made available to Faculty Senators.
- New York City's formal Request for Proposals, to which Cornell is presently responding, will be electronically posted on the University Faculty website.
- Prior to October 28, Cornell-generated materials are sensitive for competitive reasons, and therefore will be made available to Senators in the Dean of Faculty's office.



Materials available in the Dean of Faculty's office

- ✓ Cornell's confidential submission (March 2011) to the Request for Expressions of Interest (RFEI)
- ✓ An August 2011 presentation made by Provost Fuchs to the Cornell senior leadership (deans, vice presidents, and vice provosts).
- ✓ CAPP's initial report of 10 September 2011.
 CAPP anticipates producing a revised version of this document including broadly solicited comments and additions.



MERGER OF ECONOMICS DEPARTMENTS AND ESTABLISHMENT OF A COMMITTEE FOR A PUBLIC POLICY PROGRAM SEPTEMBER 14, 2011

- Economics faculty from *Arts & Sciences* and *Industrial and Labor Relations* are consolidating into a single cross-College Economics department. Economists in other colleges may be adjunct members of this department.
- Provost Fuchs has appointed a committee to study the possible formation of a School of Public Policy at Cornell, chaired by Prof. Rosemary Avery (Policy Analysis and Management, CHE). Broad input is solicited; initial proposal is expected by 31 December 2011.
