Not much difference between current and S1. The Feb break felt a bit early this year, but utilizing President's Day makes sense.

I like the idea of having a later February break, as I find it to be disruptive when it comes. However, I am unsure about the idea of pushing classes later, since we already end so late compared to other schools.

Even though I don't have kids, might be nice for spring break to coincide with Ithaca-area spring breaks so CU members with families can take a vacation. Starting semester on a Thursday means students won't actually return to campus until the following week.

This does not seem very different, though I do like the February break coming a week later. That extra momentum build in the first weeks is good for my syllabi

I don't have strong feeling either way about the differences between S1. Either works, so far as I can see.

I'm not sure how many people are inconvenienced by adding child care days. Agree with a shortened exam period.

The current February break feels too early when there are less than 3 full weeks of classes prior to it, but I do not think this outweighs the benefit of having it in synch with ICSD break.

A later Feb break has some advantages in terms of early evening prelims that I regularly face. Shortening study/exam and a later start are not positives, but they are also not large changes here.

I see almost no difference here.

I like the study days together, and it's great that we start a tiny bit later, but it doesn't seem to make very efficient changes.

Spring Break is ridiculously late. Delaying Feb break helps--it comes far too early--but not sure if this really improves things.

Not sure why the need to start on a Wednesday vice a Tuesday in Jan. What would happen if added a study day in May as the original schedule has so you start with: 4 study days on Thursday, then 4 exam days, one study day, followed by 3 exam days? The Feb break move is a good thing as it does seem to come too soon in the semester.

I don't see what this schedule accomplishes.

Seems to have little effect

Seems the same

Not much of a change

Not sure that this is an improvement, but it is perhaps the most conservative option. Nonetheless, I would like to point out that "breaks" for families with children are normally more a reason for stress than for relaxation. While I understand that the students should be at the center of any change in schedule, I still find it difficult to understand why in a little town with just a few school districts and only 2 major universities, there can not be a little bit more of consensus to make people's lives easier. If the Cornell and IC calendars can not be accommodated to fit the school schedules, why not to work with the local schools to have them match Cornell's break schedule? If this won't work, why not have Cornell's cooperative extension and outdoor recreation offer interesting, educational and low cost options for all of us that have children?

Its kind of pointless its so similar to the current. Feb break should be removed.

This seems fine to me. Changes are minimal, so I am not sure of the benefit.

The placement of February break doesn't matter as much to me, so I am fine with either option.

Does not seem to change much.

They look quite similar.

This minor change provides no real improvement, and makes the coordination with public schools even worse than it is now.

My main problem is with the two extra days at the end of February in both scenarios; I'd rather end earlier or have a longer break end of March/beginning of April.

I don't think the February break is important

I do not see the value of Feb break at all for our students.

I agree with the academic motivation for delaying the February Break, but the two child care days are problematic.

Not really sure why 2 breaks are needed. Also, the timing of spring break with other schools (not local) may not be as critical.

In this calendar a Wednesday has been dropped from the front end, compensated for by the addition of a Thursday, but this makes no sense whatsoever in terms of classes that are scheduled either MWF or TR. The result is an extra Thursday class for TR classes, and a loss of a class for MWF classes. The better and more rational solution is to start on Monday and end on a Friday--not start on a Thursday and end on a Thursday. So I would simply eliminate the two orphan days at the beginning and add on the Friday at the end.

changes are so minor I don't have an opinion

Not that different, 2 day start week is kind of silly.

I don't know child-care repercussions.

This doesn't seem all that different to me.

It makes sense to have the breaks come later in the semester. My only concern is that staff have to work on Memorial Day weekend, which doesn't seem fair. Can you start the semester one week earlier so that graduation can occur one week earlier?

This change does not accomplish much.

Our students may miss out on premium travel deals for spring break as a result, along with opportunities to connect with friends at other institutions who are on more standard calendars.

Minimal change from our current calendar

Moving one January day into May doesn't seem to address any problem, while creating new ones (again MW courses will be shorter than TR ones). It's not clear to me if postponing the february break does much, but it will certainly affect staff and faculty with small children.

Don't understand why we would move the February break from Presidents' day to a week later. This is totally nonsensical for faculty with children (does not affect me anymore but I just can't understand). Otherwise it is basically the same as current one.

i don't think that the one week delay of the February break makes much of a difference.

Not sure that this fixes the late issues with the semester. Furthermore, it only works IF the variation is chosen. You cannot lose a Wednesday and trade it with a Thursday. Classes do not work that way.
