

# SA Resolution 40: A Comprehensive Investigation into Exam Scheduling


#### The Modified Current Calendar Framework


Five-day orientation.

Increases the gap from the last exam day to graduation.


### The Early Commencement Calendar Framework


Five-day orientation.

#### **Exam Period Simulations**

Now: 13-day study/exam period with 19 exam slots over 8 days

Proposed: 11-day study/exam period with 20 slots over 7+ days

Research: We had two independent teams look at implications.

Bottom Line: Modified exam period is slightly better from the standpoint of minimizing back-to-backs, direct conflicts, 3-in-24s, etc

# Resolution Endorsing the "Statement on Academic Freedom"

# Amendment: Involves Slight Change in Statement

To commit to publicize a series of guidelines pertaining not only to academic freedom but also to academic responsibility in a climate of growing political monitoring and intimidation. For instance, Cornell should consider whether to adopt policies that prohibit the unauthorized recording or taping of classes. At the same time, Cornell should approve and make available resources designed to encourage faculty, students, and staff to fully and freely exercise their academic freedom as well as to advise and counsel faculty, students, and staff about the broad parameters of academic freedom and protected speech, given the current environment of silencing and fear.

3. To commit that Cornell will refrain from engaging in surveillance of student organizations or political groups and their faculty advisors

## **University Commitments**

Publicize a series of guidelines pertaining not only to academic freedom but also to academic responsibility in a climate of growing political monitoring and intimidation.

Refrain from engaging in surveillance of student organizations or political groups and their faculty advisors.

To reaffirm the University Faculty's 1960 "Principles of Academic Freedom and Responsibility" (Cornell Faculty Handbook).

To reaffirm the statement in the Cornell Campus Code of Conduct which protects the ability of faculty members to express unpopular or unorthodox views, analysis, and opinions.

Reaffirm that processes of faculty hiring, tenure, review, promotion, and retention will not be influenced by the candidates' political viewpoints or actions — and that the same holds true for assessment and grading of students.

To commit to foster and cultivate (financially and otherwise) existing Cornell programs and departments that concentrate on the study of and knowledge about minoritized or disadvantaged nationalities, religions, or populations and groups, particularly those that are the target of discrimination by government or private organizations.

To commit the legal resources and expertise of the University Counsel's office to support and defend faculty in the event that external entities or organizations intrude upon or otherwise violate Cornell's academic freedom and free speech protections.

# Resolution on Judicial Administrator Procedures

#### The Resolution

Title: A Proposal for Partially Redressing an Imbalance in Judicial Proceedings Involving University Administrators and Students

Whereas there exists an immense discrepancy between the power, authority, and status of a senior University administrator and that of a student,

And whereas that discrepancy is exacerbated when a senior University administrator files a complaint against a student,

Resolved, the Faculty Senate requests that proceedings in which a senior administrator prosecutes a member of the Cornell community be open and public if the defendant requests that they be open and public.

#### Substitute Amendment

Whereas the Code of Conduct, as now implemented by the Office of the Judicial Administrator, tends to exacerbate that discrepancy when a senior University administrator files a complaint against a student,

Whereas the institutional structure of the Office of the Judicial Administrator strongly encourages the office to align with senior administration officials when the latter initiate the prosecution of student protestors,

Whereas the institutional structure of the Office of the Judicial Administrator strongly discourages the prosecution of senior administration officials when they themselves violate the Campus Code of Conduct,

Whereas all members of the University community (students, staff, faculty, and administration officials) should possess equal rights, liberties, and responsibilities under the Campus Code of Conduct,

#### Substitute Amendment

Resolved, the Faculty Senate supports a revision of the Campus Code of Conduct so that it redresses the present imbalance in the respective rights of members of the Cornell Community. Such a revision should (a) clearly state that all senior administrative officials are to be held to the same standards under the Code as any other member of the Cornell community and (b) create an institutional structure in which students, staff, faculty, and senior University officials are treated equally when charged with violations of the Code
