Re: Annual Report, University Faculty Library Board, 2019-20

The Faculty Library Board (FLB) held six regular meetings during the 2019-20 academic year; in response to the COVID-19 public health situation and the Library's key role in reactivation plans for campus, the Board also decided to meet through the summer, adding meetings in June, July, and August.

Neema Kudva (AAP) and Alec Pollak (grad) joined the board this year. Most board members continued their service from last year: Eilyan Bitar (Engineering), Nancy Chau (Human Ecology), Abby Cohn (Arts & Sciences), Alice Colby-Hall (Arts & Sciences), J. Ellen Gainor (Arts & Sciences), Andrew Hicks (Arts & Sciences), Lee Humphreys (CALS), Karim-Aly Kassam (CALS), Ellis Loew (Vet), Jonathan Ochshorn (AAP), Chantal Thomas (Law), and Max Zhang (Engineering), along with co-chairs Jeremy Braddock and Paul Fleming (both Arts & Sciences). The Library was represented by University Librarian Gerald Beasley and the Library's Director of Collections, Kizer Walker.

Following on the FLB's activities in past years surrounding issues of openness and sustainability in scholarly publishing, the Board reserved time on each of this year's meeting agendas for updates on the Committee on the Future of Scholarly Communications, a University committee formed on the basis of recent FLB discussions. Along with this continued area of focus, the Board weighed in on a number of projects and issues with which the Library is currently engaged. The academic year started with an update from the University Librarian on the status of the Library's five areas of strategic priority (student experience, research life cycle, global impact, diversity and inclusion, work prioritization). In the fall, Board members engaged with the planning process for the future renovation of Olin and Uris Libraries. Representatives of Brightspot Strategy, LLC, CUL's consultants on the Feasibility and Program Study stage of the project, attended the October meeting of the FLB via video feed to register feedback and answer questions, many of which had to do with the future role of the physical collection and balancing space needs for print materials and public services.

In December, FLB members heard a presentation by Adam Chandler, who is coordinating CUL's suite of "Privacy Services," on the Library's services to protect the intellectual freedom and privacy of Cornell students, faculty, and staff, particularly in the online environment (see <a href="https://www.library.cornell.edu/services/privacy">https://www.library.cornell.edu/services/privacy</a>). Early in 2020, the Board reviewed a draft of the Faculty Library Survey that CUL had planned to conduct in March and April. At the January FLB meeting, members provided valuable input on wording and flow of questions and scheduled a follow-up meeting with Library Assessment and Planning staff in February. When the COVID-19 crisis hit in March, the survey was postponed with dates still to be determined.

The March and April meetings took place during the Cornell campus closure and were conducted via Zoom. In March, Kizer Walker, CUL's Director of Collections, presented on ongoing planning for a transition to a new staffing and budgeting model for collection development. He also reported on the Library's refocusing of efforts toward the new imperative of improving remote access to collections for the context of social distancing and the dispersal of faculty, students, and staff due to the public health

emergency. By April, the Library had enacted a number of new services and processes to support academic continuity during the COVID-19 pandemic. Most of the April meeting was devoted to open discussion of needs, ideas, and measures being taken. The Board also discussed the status of the Cornell Open Access Publishing (COAP) fund, which is administered by the Library to provide "reasonable processing fees for open access publications by eligible Cornell authors when funds are not otherwise available." Kizer Walker, who manages the COAP program, reported on recent trends in use of the fund, which perennially falls short of campus need. FLB recommended that the COAP program be continued and that CUL discuss its future support with the Graduate School, considering COAP's important role in supporting grad student publishing. Also at the April meeting, a Board member proposed that FLB continue meeting through the summer months this year in light of the exceptional challenges posed by the COVID-19 situation; the FLB agreed and meetings were subsequently scheduled for June 16, July 16, and August 17.

The first of the exceptional summer meetings took place in the wake of a series of recent killings of Black people in America and the nationwide demonstrations, organizing, and self-scrutiny that have responded to these acts. The meeting included fruitful discussion of how the Library might best respond to the call to action on systemic racism and structural inequality in Martha Pollack's June 3 message on "Immediate actions to support and strengthen our community." In the immediate term, CUL is making ebook copies of Ibram X. Kendi's *How to Be an Antiracist* freely available to all Library staff members as part of the Campus Community Book Read proposed by President Pollack. Some FLB members stepped forward to assist the Library in work on longer-term strategies. The Board also reviewed the Preliminary Report of the Return to Campus (R2C) Library Task Forces and discussed plans for the phased reopening of Library facilities, including resumed access to the print collections.
