## What is the Goal of the Requirement?

# Martha's Request (July 26)

The creation and implementation of a for-credit, educational requirement on racism, bias and equity for all Cornell students.

### **A&S Social Difference Requirement**

Courses in this area examine social differences relevant to the human experience. Social categories include class, race, ethnicity, indigeneity, nationality, language, religion, gender, sexuality, and ability as objects of study. Students develop a deeper understanding of these categories and their intersections.

Topics may include: how hierarchies in power and status shape social differences; how social, economic and political systems can impact the interpretation of social differences; and how differences attributed to various groups are explained. Every A&S student who matriculates 2020 or later must take at least one of these courses.

### From the Faculty/Grad Student/Staff Petition

IM7. Embed decolonized readings in every possible course at Cornell, including but not necessarily limited to the social sciences and humanities.

Such curricular offerings must go beyond diffuse and vague "diversity" course requirements, such as the social difference requirement in the College of Arts and Sciences.

## DRAFT of a Goal Statement of the Faculty Education Requirement

The goal of the requirement is to ensure that all faculty understand the implications of structural racism through its history on campus and within their disciplines and that they are sufficiently skilled to act on that knowledge as part of their responsibility to students.

## CALS Diversity Requirement

All courses that satisfy the Human Diversity requirement have at least 50% content in one of the following areas:

- critical analysis of historically or contemporary marginalized\* communities
- examination of diverse processes that produce unequal power relations in terms of race, nationality, ethnicity, sexuality, religion, gender, age, or economic status.
- review of the challenges of building a diverse society
