## URRC Committee Mission and Makeup

The URRC provides University oversight for hiring active military personnel that will serve as military instructors in the Cornell ROTC programs. The committee is composed of tenured Cornell faculty members from multiple colleges and the head (and executive officer) of each service branch as a courtesy.

As a committee, we interview potential candidates (typically via videoconference) for open positions within the ROTC programs. We discuss each candidate as a committee and vote to approve or disapprove of the appointment. The service branches extensively vet candidates before being interviewed by the URRC.

The committee conducted three rounds of interviews during AY 2021 - 2022

1. Captain Scott A. Hardy (ROTC Navy) on 09/30/21 at 8 AM - 8:45 AM.

**Notes:** A quorum of the committee was present, along with a representative from each service branch. The committee interviewed CAPT Hardy for the position of Commanding Officer (CO) of the Naval Reserve Officer Training Corps (NROTC) Unit, with the rank of Courtesy Professor of Naval Science at Cornell University.

CAPT Hardy was approved unanimously by the committee. He will be the replacement for CAPT Roach, who is being reassigned after completing this duty assignment.

2. Major (Promotable) Stephen M. Mallory (ROTC Army) on 11/17/21 at 1 PM - 2 PM

**Notes:** A quorum of the committee was present, along with a representative from each service branch. The committee interviewed MAJ Mallory for the Commanding Officer (CO) position of the Army Reserve Officer Training Corps (AROTC) Unit, with the rank of Courtesy Professor of Military Science at Cornell University.

MAJ Mallory was approved unanimously by the committee. He will be the replacement for LTC Tully, who is being reassigned after completing this duty assignment.

 Three candidates for three open positions in the Air Force Reserve Officer Training Corps (AFROTC) Unit were interviewed on 01/10/22 from 1 PM - 3 PM: MAJ Joshua Stevens, MAJ Derek Hall, and LTC Joshua Kirkum

Location: Zoom Chair: Charles F. Aquadro (J.Varner was traveling). **Notes:** A quorum of the committee was present, along with a representative from each service branch. The committee interviewed the three AFROTC candidates on Zoom (30 min brief was given by each candidate, followed by questions).

All candidates were approved unanimously by the committee. Each candidate will fill an open Instructor position in the Air Force Reserve Officer Training Corps (AFROTC) Unit starting in AY 2022 - 2023.

For each case, appointment documentation was signed by the committee chair and the corresponding service branch representative and filed with the Dean of the University Faculty.

## Additional business

In addition to interviewing candidates for open positions, Dean De Rosa, the URRC committee chair, Varner, and members of each service branch met (via Zoom) on 12/13/21 to discuss the issue of the disparate treatment of ROTC course credits among Cornell's colleges.

No resolution was obtained at this initial meeting. However, a follow-up meeting on 2/9/22 between Dean De Rosa, Prof. Varner, and Prof. Katherine McComas, Vice Provost for Engagement and Land-Grant Affairs, discussed strategies to address this issue. Thus, efforts are ongoing.
