Dean De Rosa's summary of the Global Hubs initiative, with the emphasis on exchange of students, reinforces Risa Lieberwitz's point about the importance of protecting our students who study abroad. We also have to make sure that students from China and elsewhere on the Ithaca campus remain free to express their views without facing intimidation from other students who might be following instructions from their government or acting on their own accord. We have learned of examples of both of these challenges to students' academic freedom in China and in Ithaca, but they could arise in any countries with which Cornell is connected.
